The Institute complements and extends the core research expertise of UCD Schools and Institutes, interwoven with international and national partnerships. Membership is drawn from several UCD Schools and Colleges and has increased by over 14% since 2020.

VISION



KEY HIGHLIGHTS

EXPERT NETWORK FOR ANALYTICAL SUPPORT IN SOCIAL POLICIES (ENASSP)

A team from the Geary Institute and the School of Social Policy, Social Work and Social Justice have been appointed Irish national coordinators of the ENASSP. It provides timely and high-quality independent information to the European Commission on social protection and social inclusion policies.

In March and April this team contributed two reports to the ENASSP, these examined: Ireland's Implementation of the European Child Guarantee Policy Responses to Energy Poverty in Ireland.

European Social Survey 10 Data Release:

The 3rd release of the European Social Survey Round 10 data was issued by the ESS data archive on 11th of May 2023.

This latest release included Irish data together with Belgium, Cyprus, Ireland, Israel, Latvia and the United Kingdom.

This means that data from all 31 countries who took part in Round 10 (2020-22) is now available via the ESS Data Portal together with the survey documentation and other metadata.

HORIZON EUROPE-FUNDED RESEARCH:

EQUALSTRENGTH

From one closed door to another: Cumulative Discrimination and prejudice against marginalised groups in Europe' - (EQUALSTRENGTH) has been approved for funding under the Horizon Europe RIA call. The project officially launched in April 2023, led by Dr. Mathew Creighton, UCD School of Sociology and Geary Institute for Public Policy, the consortium comprises 10 partners across Europe and has a budget of over €2.3 million. The project is managed by Ms Emma Barron, Geary Institute for Public Policy and Dr Daniel Capistrano, UCD School of Education, has been appointed as the post-doctoral researcher.


MEMBERSHIP

The Institute seeks to combine excellence, through publications in leading international journals, with relevance, through contributing robust evidence to inform policy making and debates. With a current membership of 122, the Institute hosts over 30 researchers (PIs and their teams and associated research visitors) together with over 50 doctoral students across a number of disciplines. In 2022/23, new members were appointed from the Schools of Economics, Education, Nursing, and Social Policy, Social Work and Social Justice.

Members are actively involved in the weekly seminar series and also the Geary Institute Research Skills Initiative Masterclasses, as well as contributing to the working paper series. The Directorate engages with members on a regular basis directly, through events and the Geary Institute weekly bulletin.

The re-established Executive Committee comprises nine members, drawn from Schools represented in the membership. The Executive meets on a quarterly basis to provide guidance on research priorities, funding pipelines, Visiting and Adjunct appointments, facilities and research infrastructure, etc.

RESEARCH

UCD CONTEXT AND RESEARCH STRENGTHS

The Geary Institute currently has 122 active members and provides research facilities, administrative and IT support to over 30 researchers and 50 doctoral students. From 2017–2023 Geary Institute fellows published more than 1,700 peer-reviewed research papers and other publications. In the same period, recurrent research income from both national and international funding agencies totalled more than €27.5m.

Research strengths at Geary map across the four key themes of **Rising to the Future**, **UCD's Strategy 2020–2024**, and have particular relevance to **Empowering Humanity and Creating a Global Sustainable Society**, especially at the interface between sustainability and equality. Contributions to **Building a Healthy World** are expected to grow with increased membership from the College of Health Sciences. With fellows drawn from over 20 Schools and across four Colleges in the University, the Institute is well positioned to forge collaborations across programmes and funding streams.

By interacting across these disciplines and through linkages with national and international initiatives, UCD Geary Institute researchers ensure that their contributions are relevant to a broad spectrum of academic, social and policy arenas.

Philip J. O'Connell is Emeritus Professor at UCD. He was Director of the UCD Geary Institute and Professor of Applied Social Science at University College Dublin from 2013 to 2021. He has an enduring interest in equality at work and in access to employment, and in the experience of migrant workers in Ireland. Michelle Norris is Professor of Social Policy and Director of the Geary Institute for Public Policy at University College Dublin. Her teaching and research interests focus on housing policy and urban regeneration. Orla Doyle is an Associate Professor in the School of Economics and a Research Fellow at the UCD Geary Institute for Public Policy. The core focus of her research is the economics of human behaviour. They each represented at the National Economic Dialogue as speakers contributing their expertise to the conference.

RESEARCH OUTPUTS

WORKING PAPER SERIES

The Institute publishes a working paper series which provides members with an opportunity to publish early versions of their analyses. This is published on the Institute's website and also on the RePEc (Research Papers in Economics) Ideas website, which aims to enhance the dissemination of research in economics and related social sciences (www.repec.org). A full list of working papers published to date for 2022/23 can be found in Appendix IV.

The RePEc rankings of publications in economics are an important metric of scientific impact. The Institute working paper series on **www.repec.org** achieved over 4,594 abstract views and 1,100 downloads in the year up to 30 April 2023.

The Geary Institute is ranked fifth in Ireland and is consistently in the top 12.5% of economic institutes/ schools in Europe (currently position 298 in the table). It is also in the top 25% in the IDEAS 'think tank' category in Europe. IDEAS is the largest bibliographic database dedicated to Economics and is based on RePEc, Research Papers in Economics, which is a collaborative effort of volunteers to enhance the dissemination of research in economics and related sciences.





RESEARCH FUNDING AND PROJECT HOSTING

European Commission Establishment and management of an Expert Network for Analytical Support in Social Policies (ENASSP)

This project is led by Professor Michelle Norris, UCD Geary Institute for Public Policy, Dr Dorren McMahon, UCD Geary Institute for Public Policy, Dr Micheál Collins, UCD School of Social Policy, Social Work & Social Justice and UCD Geary Institute for Public Policy and Dr Maria Pierce, UCD School of Social Policy, Social Work & Social Justice. The project will establish, organise, manage and coordinate a network of independent national social policy experts and it will be responsible for the secretariat of the governmental experts on social protection systems (the Mutual Information Systems on Social Protection [MISSOC]). A key purpose of the ENASSP is to provide timely and high-quality independent information to the Commission on social protection and social inclusion policies in the countries covered by the network (award €72,000).

EqualStrength project has been approved for funding under Horizon Europe

The project is led by Dr Matthew Creighton of the UCD School of Sociology and Geary Institute for Public Policy, comprises partners from ten other European research institutions, and is supported by funding of €2,394,901. This research project objective is to investigate cumulative and structural forms of discrimination, outgroup prejudice and hate crimes against ethnic, racial and religious minorities. Assessing Administrative Burdens as Barriers to Implementation of Ireland's Climate Action Plan (ABICAP)

This project is led by Dr Leohnard Lades, School of Architecture, Planning and Environmental Policy & UCD Geary Institute for Public Policy. Overall budget €199,015.

Background: The Government of Ireland is currently at the early stages of implementation of the National Climate Action Plan. The EPA-funded ABICAP project aims to support the implementation of the measures outlined in the Climate Action Plan by identifying whether administrative burdens create unnecessary frictions in the system and are thus reasons for the gap between climate aspirations and climate actions. While administrative requirements are often essential for program integrity, avoidance of environmental harm, accountability, and transparency, ABICAP focuses on instances where administrative burdens are unnecessarily high, where they are unjustly distributed, and on the reduction of unnecessary administrative burdens. Key research questions: What are the unnecessary administrative burdens that impede the implementation of the policies described in Ireland's 2021 Climate Action Plan? Who suffers more than others from these administrative burdens? How can these administrative burdens be reduced?

Methodologies: To answer these questions, the ABICAP team will (i) review the international evidence on best approaches to identify and, if necessary, reduce administrative burden; (ii) Identify policies in Ireland's National Climate Action Plan in which administrative burdens are most prevalent and unnecessary using qualitative semi-structured interviews with key stakeholders; (iii) develop a set of recommendations about which administrative burdens could be reduced as identified in a citizen-led "Adminathon" (which is similar to a "hackathon" but where participants work to reduce administrative burdens rather than collaborating on a software project); (iv) identify segments in the population that suffer the most from the administrative burdens identified in the qualitative interviews using a nationally representative online survey, (v) experimentally test the effects of modifications of administrative processes (as identified in the Adminathon) on behaviour; and (vi) collate and systematise the insights gained to design a framework in the form of a policy scorecard to build an inventory of administrative burdens.

Team: The ABICAP team is Dr Leonhard Lades (lead), Dr Cara Augustenborg, Dr Margaret Samahita, and Lucie Martin. ABICAP is based in the Geary Institute and the School of Architecture, Planning and Environmental Policy.



Preparing for Life (PFL) Age 13

Preparing for Life (PFL) is a community-led initiative operated by the Northside Partnership in Dublin which was initially evaluated over an 8-year period (2008-2016) by the UCD Geary Institute for Public Policy under the direction of Dr Orla Doyle. PFL is now the longest running experimental intervention programme in Europe and has resulted in over 25 academic articles and multiple policy reports. In 2023, the team will go back into the field to assess the impact of the programme at age 13. This work demonstrates the importance of investing early in life to break the intergenerational transmission of disadvantage.

The European Social Survey (ESS11)

University College Dublin has played a central role in the development of the European Social Survey. Our team has been appointed as the National Coordinator of the European Social Survey in Ireland for both Round 9, Round 10 and now for Round 11. ESS 11 Ireland is supported by the Irish Research Council (IRC). The fieldwork partner for ESS 11 is Behaviour and Attitude (B&A). The team consists of Dr Micheál Collins, Dr Mathew Creighton, Dr Ebru Işıklı, Dr Sarah Carol, Ms Emma Barron and Dr. Dorren McMahon.





The Building International Collaborations Supports (BICS)

The Geary Institute issued a call to members in May seeking applications for its new seed funding scheme titled The Building International Collaborations Supports (BICS). The BICS initiative is designed to foster greater collaboration between Geary members and researchers in universities and research institutes outside Ireland. BICS aims to support visits by international collaborators to UCD during the 2023/24 academic year by providing both access to desk space for visiting scholars in the Geary Institute and also funding for vouched travel and accommodation costs of between €300 and €2,500 for nominated international collaborator(s). The visits can be between one week and one academic vear in duration but should support the initiation of new collaborations or the further development of existing research collaborations that will lead to significant outputs in terms of publications and/or research funding applications.

The deadline for the call was Friday, 26th May 2023. We were delighted with the great interest and response rate to the call and received eleven excellent competitive applications for funding. Our team assessed all eleven applications and shortlisted the following seven successful applications:

Our successful visiting scholars will be required to spend a minimum of 1 week in the Geary Institute for Public Policy, with the possibility of further joint research work beyond this timeframe. During their stay, the UCD Geary Institute will provide successful candidates with access to a work area, and internet facilities, if necessary. The total amount of BICS Scheme funding granted is €9814.

The successful candidates are expected to:

- deliver a research seminar on a relevant topic of their current work during their visit to the Institute as part of the UCD Geary Seminar Series or participate as a speaker in one of the Institute's scheduled events.
- draft a brief on an area of their expertise and interest, to be published under the UCD Geary Institute banner in either pp.ie or in the form of a Geary working paper and circulated among the Institute's mailing list.
- engage in research with one or more of the UCD Geary Institute's core members. This work should lead to at least one high-quality academic output within 24 months of the fellowship's completion, or a funding application or research event or other outputs that could create significant impact from the results of the joint research.

RESEARCH CENTRES BASED AT GEARY

SOHAM Lab - Sociology of Humans and Machines

The Institute has welcomed in **Taha Yasser**i, Associate professor of Sociology and Director of the groundbreaking SOHAM Lab - Sociology of Humans and Machines. This lab has been provided with a project office which accommodates two postdocs and two PhD students. Here they are taking a holistic approach to the Sociology of Humans and Machines and trying to understand how our new hybrid societies function and how this new ecosystem should be built, harnessed, and governed. Launched on the 11th of October 2022 as one of the Geary weekly Seminar Series, the Geary Institute hopes to continue in its purpose of supporting important projects for public policy.

UCD Childhood and Human Development Research Centre (CHiLD-RC)

The CHilD-RC at UCD is a collaborative interface across the Bio-Psycho-Social Sciences which aims to enhance our understanding of children's wellbeing and human development through producing an integrated interdisciplinary knowledge base. Research on childhood and its consequences for life-course wellbeing has reached a point where collaborations between numerous disciplines are needed to produce ground-breaking research and inform policy.

The aim of the CHilD-RC is to create a space for such collaborations to respond to important challenges and create insights into how early biological, psychological and social mechanisms affect lifecourse health and wellbeing. Through its research, the Centre aims to contribute to this knowledge base which can then be used by policymakers and practitioners to enhance child wellbeing. The Centre, which is based in Geary, brings together UCD-based researchers who apply a range of quantitative, qualitative and mixed methodological approaches in researching all aspects of children's lives, from the early years through to adulthood.

UCD Behavioural Science and Policy Group

The Behavioural Science and Policy Group is a centre for research and collaboration on integrating behaviourally informed ideas into public policy. The research team consists of a core group of faculty, researchers and PhD students, a wide network of research affiliates and external stakeholders. The Centre's aims are to contribute to the international development of the field of behavioural science and to be a key site for integrating this field into public policy. Using methodologies such as lab and field experiments, surveys, secondary data analysis and economic theory, the Centre conducts research on the following topics:

- Psychological determinants of decision-making (e.g. self-image and identity, social image, emotions, self-control)
- Subjective well-being
- Economics and mental health
- Ethical uses of behavioural insights
- Administrative burden and 'Sludge'
- Political behaviour and preferences
- Discrimination

Governance by Numbers and its Discontents

The invited speakers were Maurizio Atzeni (Universidad Alberto Hurtado, Chile), Sarrah Kassem (Universität Tübingen, Germany), Valeria Pulignano (KU Leuven, Belgium), Kurt Vandaele (European Trade Union Institute, Belgium) and Alex Wood (University of Bristol, UK).

The ERC project members presented among others at the 13th International Labour and Employment Relations Association (ILERA) European Congress (September 2022), a conference of the Jean Monnet Network 'Transnational Political Contention in Europe (TraPoCo)', of which Roland Erne and Darragh Golden are member alongside their ERC project commitments, gave a guest lecture in a module at the University of Padua, Italy (November 2022), and outreached to practitioners in the field through contributions to the European Works Council (EWC) Conference in Dublin hosted by the Germany-based EWC Academy (March 2023), and the European Public Services Union's (EPSU) Health and Social Services Standing Committee 58th Meeting in Brussels (February 2023).

15th Annual Economics and Psychology Conference

The 15th annual one-day conference on Economics and Psychology was held on 16th of December 2022 in TU Dublin City Campus. It was jointly organised by the UCD Behavioural Science and Policy Group located at the UCD Geary Institute, the ESRI Behavioural Research Unit, and the Department for Psychological and Behavioural Science at LSE.

Geary Institute for Public Policy Research Forum

The Geary Institute organised a research forum which discussed the following topics: "Life under Coronavirus: the experiences and views of children across the world"; "How Pandemic Shock Affects Claim for Minimum Income Measures"; and "Alcohol use and health utility: a Mendelian randomization study" presented by Prof Jeremy Bray. This took place on the 8th of February 2023 between 14:00 and 16:15 pm in the Geary Seminar Room (B003/B004).



Impact 2030: Strategies for strengthening the impact of research on policy

The Geary institute organised a discussion with Deirdre Lillis, Assistant Secretary General for the Department of Higher Education, Research, Innovation and Science on 26th of October between 13:00 and 14:00 pm in the Geary Seminar Room (B003/004). The discussion was chaired by President Orla Feely.

The event discussed 'Impact 30,' a research and innovation policy statement alongside plans to strengthen engagement between researchers and policymakers. The event provided an opportunity for UCD researchers who conduct policy relevant research to engage with policy makers and to discuss ideas for strengthening the links between researchers and policy makers.

Workshop on Behavioural Science and Sustainable Food Consumption

This event was run by The Behavioural Science and Policy Group.

The aim of the workshop is to bring together behavioural scientists who work on sustainable food consumption. The workshop will offer opportunities to present our research on the topic, to explore opportunities for future joint projects, and to reflect on the state of behavioural research in this area more generally. The workshop was held on 26th October 2022 and was held in hybrid format.

GEARY INSTITUTE RESEARCH SKILLS INITIATIVE (GIRSI)

TALKING ABOUT LAND FOR AFFORDABLE HOUSING: LAND POLICIES, SUBSIDIES AND REGULATION:

The Geary Institute joint seminar series with the Housing Agency and the Land Development Agency commenced on the 4th of October. 240 people attended the first of these sessions which was held in a blended format. The second which was held on 18th of October on Public Land Banking, had an attendance of 30 in person and 220 online. Each subsequent event has been a resounding success. January saw the return of the series with the first seminar on Land Value Capture, taking place on the 10th. This was followed by Land Value Tax on the 24th of January. The final seminar examined Inclusionary Zoning and took place on 7th February.





PUBLICPOLICY.IE

PublicPolicy.ie is an online platform for informing academic and contemporary debates about public policy in Ireland. Established in 2012 with support from Atlantic Philanthropies, it was incorporated into the Geary Institute for Public Policy in 2019. The aim of the Public Policy website is to provide independent evidence to inform economic, social and environmental policies by communicating policy-related research findings and information in an accessible way to policymakers, non-specialist academics and members of the public. The platform is independent, has no party-political association or view, and is not aligned with any sectional interest.

The online platform is a resource for research and information which is disseminated in two main ways. First, it highlights key policy-relevant reports that have been published externally, through the website's 'Policy Register' function. Between June 2022 and June 2023, the website disseminated 62 external policy reports. Second, it disseminates original research papers that have been written in a clear, accessible way for non-specialist audiences and which cover an array of policy-related issues. Between June 2022 and June 2023, 24 papers were published on

the website. Most of these papers focused on one (or more) of the following areas: health, the impact of Covid-19, education, and the environment.

Since June 2021, two postdoctoral research Fellows have managed the content for the Public Policy website: Valesca Lima (2021) and Laura Foley (who started in January 2022). Laurie Reilly joined the team in January 2023. The full list of papers and authors is below.

POLICY ENGAGEMENT

The Geary Institute aims to increase levels of engagement between researchers and policy practitioners in Ireland and beyond. The following section highlights policy engagement activities in 2022–23.



An Chomhairle Náisiúnta Eacnamaíoch agus Shóisialta National Economic & Social Council

The National Economic and Social Council advises the Government on economic, social and environmental policy. Geary Institute fellows Prof Colin Scott (Principal of the College of Social and Law) and Prof Niamh Moore Cherry (School of Geography) were appointed as independent members of the Council for a five-year term in 2022.

HOUSING COMMISSION

In December 2021, Professor Michelle Norris was appointed to the Commission on Housing established by the Minister for Housing, Local Government and Heritage. The Commission is due to report to the government in autumn 2023.

IRISH GOVERNMENT ECONOMIC EVALUATION SERVICE EXTERNAL ADVISORY COMMITTEE.

Geary Institute Director Professor Michelle Norris has been appointed to the External Advisory Committee of the Irish Government Economic Evaluation Service.





INFRASTRUCTURE AND HUMAN CAPITAL

SPACE AND EQUIPMENT

The Geary Institute building offers the following supports for researchers.

BEHAVIOURAL LAB

The Behavioural Science and Policy Lab is the Institute's dedicated laboratory space to conduct studies in experimental economics and economic psychology. It features 16 computer terminals for participants and one for the experimenter. All terminals are separated by dividing walls to ensure participants' privacy. The computers feature Windows 10 and z-Tree. Additional software can be installed on request.

ZOOM ROOM AND BOARDROOM

The large library/meeting room is suitable for meetings of up to 20 people. Technology to facilitate blended meetings is available to Fellows. For PhD students and researchers who work in shared offices, there is also a dedicated office where online meetings can be held.

BICS (BUILDING INTERNATIONAL COLLABORATION SUPPORTS) SEED FUNDING SCHEME

In May 2023 the Geary Institute launched a new seed funding scheme for members. The Building International Collaborations Supports (BICS) initiative is designed to foster greater collaboration between Geary members and researchers in universities and research institutes outside Ireland.

BICS will support visits by international collaborators to UCD during the 2023/24 academic year by providing both access to desk space for visiting scholars in the Geary Institute and also funding for vouched travel and accommodation costs of between €300 and €2,500 for their nominated international collaborator. These visits can be between one week and one academic year in duration but should support the initiation of new collaborations or the further development of existing research collaborations that will lead to significant outputs in terms of publications and/or research funding applications.

PHD SPACES

To facilitate the growing number of PhD space applications, the Institute provided an extra office to provide further desk space as well as the open plan space to hold 50 PhD students. Applications for desk spaces are accepted each summer for the coming academic year. A monthly seminar is run by the PhD student.

BUILDING UPGRADES

A series of refurbishments and upgrades to Institute offices and facilities, including PhD space, project offices and researchers/visitor offices, got underway in late 2022 and are continuing to take place.








