

University College Dublin Governing Authority Summary of Ordinary Meeting 22 June 2023

- 1. The Governing Authority approved the minutes of the meeting of 11 May 2023.
- 2. The Governing Authority noted the President's Report.
- 3. The Governing Authority noted the Acting Registrar's update.
- 4. The Governing Authority noted the Students Union update.
- 5. The Governing Authority noted the update of the Select Committee.
- 6. The Governing Authority noted the results of the staff elections for the internal members of the Governing Authority.
- 7. The Governing Authority authorised the signing by the Chair and President of the document (S.I. 582 of 2014 as amended in relation to the UCD pre-2013 Model Pension Scheme) submitted to the meeting.
- 8. The Governing Authority approved the €350m EIB loan facility to be drawn down subject to HEA agreement and EIB approval.
- 9. The Governing Authority approved the updated Treasury Management Policy.
- 10. The Governing Authority approved a €5.6m spend on full implementation of a UCD-wide Student Relationship Management system.
- 11. The Governing Authority agreed in principle to implement FinPOST as a replacement for UCD's current finance system and approved €3.1m in spending to continue the project up to December when a fully designed and tendered business case will be presented.
- 12. The Governing Authority delegated authority to FRAMC to award the contract for the Sports and Student Amenities enabling works, landscaping, and pitches at a special FRAMC meeting over the summer, up to a limit of €20 million.
- 13. The Governing Authority approved an increase to the Sports and Student Amenities Masterplan budget from €7.3m to €7.7m to allow the project to proceed to Stage 3 and issue tender documents for the main works contract.
- 14. The Governing Authority approved the budget and the award of the main contract for Science Phase 3, subject to HEA approval.
- 15. The Governing Authority approved the University budget 2023/2024 and Five-Year Financial Plan.
- 16. The Governing Authority noted the Employee Code of Conduct and Implementation Plan.
- 17. The Governing Authority approved the Charities Annual Return and Compliance Record Form 2021/2022.
- 18. University Secretariat to prepare an updated response to the external effectiveness review recommendation for approval at the September 2023 Governing Authority meeting.
- 19. The Governing Authority noted the progress update on the CINNTE Institutional Quality Improvement Plan.

- 20. The Governing Authority noted the update on the 7-year cycle of quality review.
- 21. The Governing Authority approved the Selection Committee membership and noted the update on the appointment of the Registrar process.
- 22. The Governing Authority noted the proposal for the new position of Vice-President for Strategy and External Engagement.
