### **UNIVERSITY OF BELGRADE**



Faculty of Medicine University of Belgrade (MFUB), founded in December 9, 1920, is one of the oldest institutions of Higher Education in Serbia. Over the past decades, MFUB was successfully completed by more than 37 000 MDs, 3 500 candidates obtained the title of Master in Medical Sciences, and 2 600 candidates successfully defended their Doctoral dissertations, which contributed to our Faculty becoming the leading institution for Medical Education in the country, together with its significant position in the regional framework.



### UNIVERSITY OF BELGRADE FACULTY OF MEDICINE

In accordance with the Law on Higher Education and Standards of ORPHEUS (Organization of PhD Education in Biomedicine and Health Sciences in the European System), MFUB organizes Doctoral academic studies (DAS) in medical sciences and offers 22 modules. The latest PhD program in medical sciences was accredited in the academic year of 2016/2017 and it includes a broad range of basic, preventive and clinical thematic fields.

#### REQUIREMENTS

#### General requirements for all the modules:

- Grade Point Average from the previous level of studies at least 8.00;
- English language skills: ability to communicate and monitor the scientific literature;
- Adequate computer skills;
- Recommendations for scientific research (preferably).

Special requirements are defined for each module.

The selection of candidates is carried out by the corresponding Program Council based on the fulfillment of the requirements of the call, including the following:

- Grade Point Average from the previous level of studies -50%;
- previous candidates' research experience 30%;
- individual preferences and abilities of candidates assessed through the interview with the Program Council - 20%.





FACULTY OF MEDICINE

- In both of these papers the student should **be the first author** or second author if his/her mentor is the first author.






## PhD theses and number of published papers, 2006-2017








## PhD theses and cumulative impact factor, 2006-2017
