Understanding your Diploma

This programme is suitable for persons with a professional interest in Safety and Health in the workplace, including safety advisors, managers, engineers, occupational hygienists, physicians and nurses. The Higher Diploma is recognised by the UK Institution of Occupational Safety and Health (IOSH) as an academic qualification for granting Chartered Membership of the Institution.

Admission requirements

- You should have educational qualifications of at least matriculation standard (Leaving Certificate with two honours, or equivalent and a Science subject in Physics, Chemistry, Biology or Engineering).
- · You should be a working adult.
- Priority is given to applicants who are active in Occupational Safety and Health (OSH).
- You must be at least 23 years of age and you should have at least 3 years work experience at the time of application.
- You may be recommended to first undertake a foundation programme to ensure your success on the Higher Diploma programme (e.g. safety and health, study skills, return to learning, science or other access course). This will be decided on a case-by-case basis, taking into account your previous academic and professional qualifications and work experience.

In exceptional cases, applicants who do not meet the matriculation requirements, but who have relevant work experience, may be considered on mature grounds. Such candidates must include a mature applicant portfolio to support their application. A portfolio would normally include evidence of successful completion of a course, which may approximate matriculation, and/or experience and training in OSH, and evidence of a good understanding of the basic sciences. Mature applicants must be working in the area of Occupational Safety and Health. If you are considering submitting a portfolio, contact the programme coordinator at 01-716 3420.

Mapping your Diploma

- This programme is mapped at level 8 on the National Qualifications Authority of Ireland (NQAI) framework.
- Because this is a multidisciplinary programme, you will be able to progress to a variety of cognate professional and/or graduate programmes, mediated by their existing multidisciplinary qualifications.
- Please note that the UCD Certificate in Safety and Health at Work is not nested in the Higher Diploma programme.

Commitment required from students

- The Higher Diploma programme is designed to be completed over two full years (6 semesters), September to July each year.
- Lectures will normally be held on Fridays (9 am 5 pm) in Stage 1 and on Tuesdays (9 am – 5 pm) in Stage 2.
- Attendance on occasional Saturdays will also be required; workplace site-visits will also take place outside of scheduled programme time.
- Programme assessment strategies are normally work-related and include continuous assessment, assignments, projects and examinations. Assignments, project work and self-directed learning may be required during the summer semester between the two academic years of study and in the final summer semester at the end of the programme.
- UCD expects that if you register to its programmes you will be in a position to commit to attending and being available on scheduled programme and assessment dates. You can see term dates for the next academic year on http://www.ucd.ie/students/keydates.html
- You must pass Stage 1 before you can progress to Stage 2.

Career opportunities

On completion of this programme, successful candidates will have met the academic competency requirements to manage occupational safety and health in a variety of workplace settings. Work experience and additional professional qualifications will determine the level of competency for any individual professional. Successful completion of the programme qualifies you to apply for

Programme fees

Fees include tuition and examination fees. The fee schedule for all programmes is shown on the UCD Fees website (http://www.ucd.ie/fees/) and refers to the fee for a single academic year, including the fee schedule for non-EU nationals and the annual fee for the outgoing year.

Important dates and information

- If your application is successful then you will be notified promptly.
- The closing date for receipt of your complete application is the last working day of June.
- Late applicants are considered if the quota is not reached by applicants who have applied on time.
- The first day of the programme will be Friday September 8th 2017.

How to apply

You apply using the UCD online application system. Simply click on http://www.ucd.ie/registry/admissions/apply.html and follow the instructions. You will be required to pay an online non-refundable application fee.

What must be provided with each application?

Your application will be reviewed when all the necessary documents are submitted, as long as they are received before the closing date. You will need to submit:

- A CV (maximum 2 pages).
- Copies of your leaving certificate (or equivalent) or post-leaving certificate diploma or degree parchments, as well as transcripts of your associated results.
- You will need to provide original documents for verification prior to registration. Please visit UCD Registry webpage (http://www.ucd.ie/registry/admissions/Apply_Verify.html) for further information.

- If you are applying on mature grounds, you must submit your mature student portfolio.
- If your first language is not English, you must submit the original certificate of completion of an English test.

English language requirements

- If your first language is not English and your primary degree was obtained in a country where English is not the official language of instruction, then you must provide proof of proficiency in English such as IELTS or TOEFL.
- You must submit the original certificate of completion of an English language test with your application.
- For IELTs (International English Language Testing System –
 Academic): a minimum overall band score of 7.0 is required with
 a result not less than 6.5 in each of the individual sections.
- For TOEFL (Test of English as a Foreign Language): Internet Based
 Test: a minimum total score of 100 out of 120 is required, with
 a score not less than 22 in Reading and Listing, not less than 26
 in Speaking and not less than 24 in the test of written English.
- For the Paper Based Test: A minimum total score of 600 is required with a score not less than 5.0 in the test of Written English.
- Test results must not be more than 2 years old.

- If you submit an incomplete application it will delay the application process; you should make sure that all sections of the online application form are completed, and include copies of all the requested documentation on, or in advance of, the deadline.
