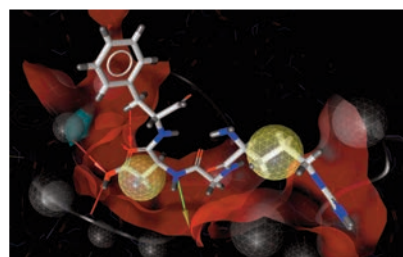
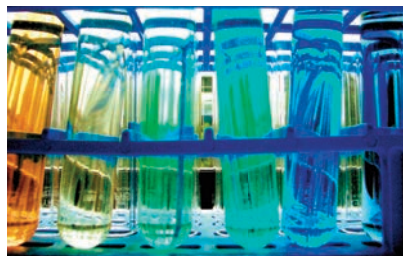
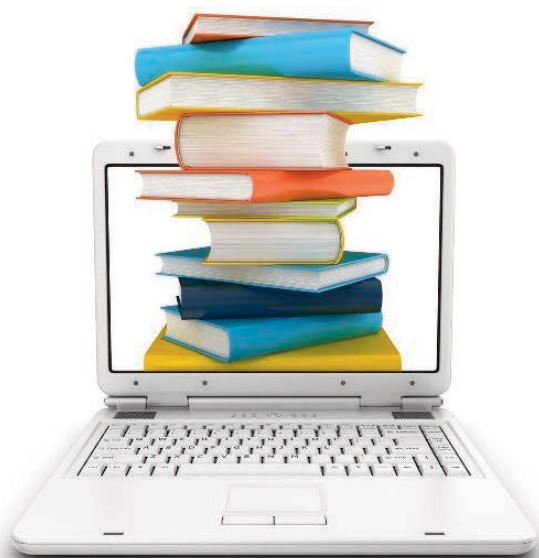

Ethical Review in UCD

Our office coordinates ethical review of research proposals involving human subjects, personal data, and animals. We process incoming applications and act as a link between researchers and research ethics committees in UCD.

Full ethical review:

- Apply online via **Infohub** (staff – Research tab) or **SISweb** (students – Programme Services tab)
- Complete the relevant application form and prepare your supporting documents and upload them as part of your online submission
- Take note of the deadline for submissions
- For step-by-step guidance visit our website

Exemptions from full review:

- Check if your project is eligible for exemption
- Complete the Exemption form and submit it by email to exemptions.ethics@ucd.ie

- **Ethical review in UCD** application and supporting documents requirements, submission process, approval process etc.
- **General ethical issues** relating to research with diverse human populations, use of personal data, research data storage & archiving etc.
- **Ethics & funded research:** screening reports and ethics self-assessment statements in major national and EU funding programmes such as Horizon2020, Science Foundation Ireland etc.
