



PROGRAMME REQUIREMENTS FOR SCHOOL OF MEDICINE & MEDICAL SCIENCE PROGRAMMES

MEDICINE (DN400) AND GRADUATE ENTRY TO MEDICINE (DN401)

As a student on the Medicine programme at the School of Medicine and Medical Science at UCD, the following compulsory programme requirements apply to each year of your study.

Please read the following text carefully. It is your responsibility to understand and adhere to each of the programme requirements as outlined below.

1. Confidentiality Agreement

During your studies at University College Dublin you will be exposed to clinical encounters with real patients and real cases. Any information relating to patient healthcare history, diagnosis, condition, treatment, or evaluation shall be considered individually identifiable health information and therefore should not be disclosed verbally or in writing. You must respect the privacy of all patients and disclose information only when given written consent from the patient concerned.

2. Ethical Consent

You must be familiar with the Guide to Ethical Conduct and Behaviour issued by the Irish Medical Council.

3. Healthcare Screening

All students entering Medicine (DN400 & DN401) are required to demonstrate evidence of immunity to certain infectious diseases. You will be required to pay a Healthcare Screening Cost of €225. This once-off charge, which becomes payable when you register, will cover pre-entry bloods, checking of MMR status, giving MMR if required, checking BCG scars and provision of HepB vaccines.

Please refer to the information leaflet entitled "University College Dublin, Medical School - Information on Infectious Diseases Procedures and General Health" very carefully.

If there is anything you do not understand about the information provided, or if you require more information, you should contact the Health Science Programme Office. You are also advised to discuss the matter with your own family doctor.

By entering the School of Medicine and Medical Science as a medical student you have agreed to:



1. Preliminary hepatitis B blood test and medical assessment prior to admission to the Medical School.

3. Vaccination against hepatitis B with follow-up testing.
4. Tuberculosis testing
5. Review of vaccination status to measles, mumps and rubella
6. Assessment of immunity to Varicella Zoster Virus (Chicken Pox)
7. Assessment of infectivity for Hepatitis C
8. Results of tests being kept by the Student Health centre or UCD School of Medicine & Medical Science Office.
9. Results of tests being supplied as needed to clinical practice sites where you may receive clinical training.

Garda Vetting

PROGRAMME REQUIREMENTS FOR BSC RADIOGRAPHY (DN410)

As a student on the BSc Radiography programme at the School of Medicine and Medical Science at UCD, the following **compulsory** programme requirements apply to each year of your study.

1. Confidentiality Statement

During your studies at University College Dublin you will be exposed to clinical encounters with real patients and real cases. Programme Requirements –BSc Biomedical, Health & Life Sciences (DN440)

As a student on the BSc Biomedical, Health & Life Sciences programme at the School of Medicine and Medical Science at UCD, the following compulsory programme requirement applies to each year of your study.

Please read the following text carefully. It is your responsibility to understand and adhere to each of the programme requirements as outlined below.

Healthcare Screening

Prior to admission to the Medical School, all students entering the BSc Biomedical, Health and Life Sciences programme must satisfy the School that they agree to vaccination for Hepatitis B and follow-up testing

As an entrant to the BSc Biomedical, Health and Life Sciences programme, you must:

1. Submit satisfactory evidence of non-infectivity for Hepatitis B prior. This will include a blood test (Hepatitis B Surface Antigen) taken by the Student Health Service prior to programme admission and analysed by the Virus Reference Laboratory, University College Dublin.
2. Any non-immune students are required to be vaccinated against Hepatitis B through the programme carried out by the UCD Student Health Service. Follow-up serology for evidence of immunity will also be required.
3. Students who show evidence of Hepatitis B infectivity will be admitted to the BHLS programme but must demonstrate non-infectivity within a maximum period of two years and may be restricted from participation in certain exposure-prone activities. Infectivity will be assessed in accordance with the Department of Health and Children's current guidelines in relation to infectivity in healthcare workers.
