UCD Past Exchange & Study Abroad Scholarships

Terms and Conditions [October 2016]

- 1. The scholarship will cover €4,000 of tuition fees for one year for students on non-EU fee rates;
- 2. These Scholarships aim to attract excellent candidates to the UCD's graduate programmes and encourage previous exchange and study abroad students to return to UCD for their graduate studies;
- 3. Candidates should have spent a minimum of one semester in UCD (Dublin campuses) as a registered exchange or study abroad student;
- 4. Candidates should have not previously been enrolled to UCD on a full-degree programme;
- 5. Candidates should be registering to a full-time Masters degree programme at UCD in the forthcoming September or January;
- 6. Scholarship awards are applicable to eligible full time Masters programmes. This is excluding the MBA programme in the Smurfit School of Business, joint masters programmes, clinical programmes, online programmes and the MSc in Digital Investigation & Forensic Computing;
- 7. Scholarships are open to self-funding candidates only and are not eligible to be combined with any other tuition scholarship;
- 8. Candidates must accept the Scholarship before commencing studies in UCD Dublin. The Scholarship award will not be applied to the students account after teaching term for applicable period commences;
- 9. Once scholarship awards are issued, students must accept this offer by the specified method within the timeframe provided and notification being distributed by the committee. It is the student's responsibility to formally accept the scholarship offer, a non-response will be considered as declining the offer;
- 10. Students awarded a Scholarship must commit to attending UCD Open Events where required. Student's must also agree to join the Student Ambassador Panel and provide testimonials, or podcasts on their experience at UCD where required;
- 11. A student who withdraws, cancels or becomes inactive, enrols less than full-time, is suspended, or dismissed from the University will lose his/her scholarship eligibility. A student who takes such a status due to medical reasons may appeal in writing to Scholarship Committee to have his/her scholarship reinstated. The appeal must be submitted with supporting documentation, such as a letter from a doctor. In such a case, for there to be a possibility for reinstatement, a student's leave from the University cannot exceed two consecutive semesters;

- 12. A student who declines an initial offer of admission and accompanying Scholarship offer will not retain his/her Scholarship offer if he/she reapplies at a later date.
- 13) Continuous full time enrolment and attendance is required to retain a scholarship award;
- 14) The issued scholarship will be deducted from your University fee account;
- 15) Scholarships are non-transferable and will only apply to the programme associated with the offer letter that contains the scholarship award;
