
- Each day, we handle approximately one-half of all trading in Irish equities







Growth Capital - Tiger Global Management



Investors are now in line to get returns of 3-4x their initial investment when the company's reverse takeover of Nasdaqlisted Jazz Pharmaceuticals closes early next year.




