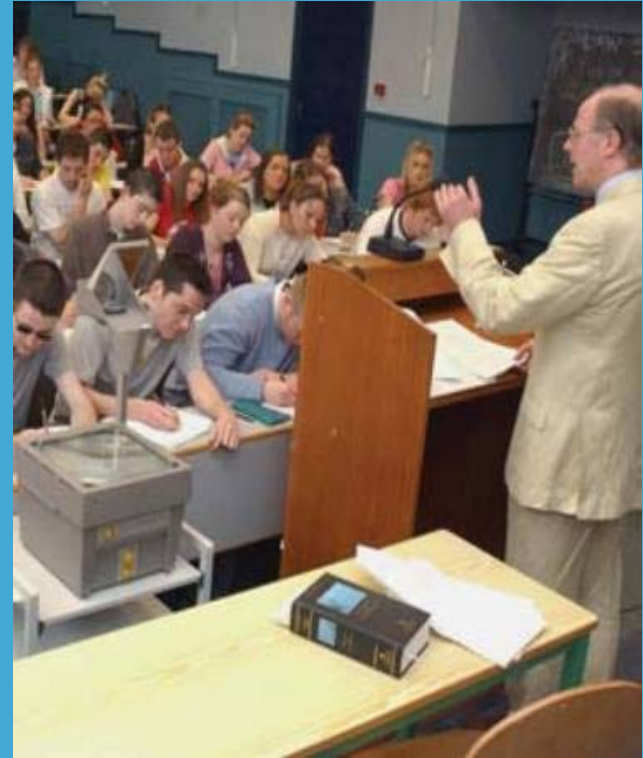

- Wide range of subject options
- Leaving Certificate entry requirements:
 - Irish, English, Maths (min Grade B3), Foreign language
- European Specialisation Option - 3rd year abroad
- International Law Specialisation Option – 4th year abroad

Stage 4

In Stage 4 students have the option to specialise in either Law or Business.

They must complete the following:

- **20 Business credits** – comprised of: 1 core module, Strategy Formulation and Implementation (10 credits) and 2 elective modules (5 credits each).
- **20 Law credits.**
- **20 Free Elective credits** – these can be taken in Business or Law or a combination of both.
