Minutes of the meeting of the Academic Council Thursday 24 November 2022, 2pm Auditorium, UCD Village

Present: 66 In Attendance: 6 Apologies: 24

This meeting of Academic Council was chaired by the Acting President, Professor Mark Rogers. The Chair requested a minute silence on behalf of the following individuals who had recently passed away:

The Chair informed members that Part 3 of the agenda is for information and Part 2 is for decision en bloc. Members were invited to indicate if they wanted any items from these parts moved to Part 1 for discussion. No items were raised.

Decision Academic Council approved items from Part 2 and noted items from Part 3 of the agenda.

1 Apologies

The Chair acknowledged that a number of apologies had been received.

2 Minutes and Matters Arising

Minutes of the meeting held on 21 April 2022

The minutes of the meeting held on 21 April 2022 were approved subject to a title correction.

Matters Arising

Item 13, AC 21/04/22, 'New and Renewed Head of School Appointments'

Academic Council was informed that Professor Suzanne Guerin's extension as Head of School was
resubmitted in error to Academic Council at its meeting on 21 April 2022 for one year only (2022-23).
The extension was already approved for two years (2022-24) by Academic Council at its meeting on
22 April 2021.

 Academic Council was informed that the Head of School appointment for Professor Orina Belton, approved from 1 September 2022 to 31 August 2027, has been postponed. The Academic Council Executive Committee (August 2022) approved the reappointment of Professor Wim Meijer for one year from 1 September 2022 until 31 August 2023.

Item 10a, AC 21/04/22, 'Election of Academic Council Members to the Search and Selection Committees for the Appointment of the President' / Item 10b' Recommendations for Elections to Search Committee and Selection Committee'

Academic Council was informed that the response from the Governing Authority to the issues raised by Academic Council regarding the procedures for the appointment of the next president of UCD, was presented under item 21 for noting on the agenda.

<u>Declaration of potential conflicts of interest or perceived conflicts of interest</u> None were declared.

PART 1 ITEMS FOR DISCUSSION / DECISION BY ACADEMIC COUNCIL

3 QQI Principles for Professional Engagements with Education Providers, including Programme Validation, Professional Accreditation and Approval

The Director of Quality Assurance, Bronwyn Molony, was in attendance to introduce this item.

The Principles document was developed by the Quality and Qualifications Ireland (QQI) in collaboration with the Higher Education Institutions, Irish Universities Association (IUA) and Professional Statutory and Regulatory Bodies (PSRBs). It provides a set of high-level principles for awarding bodies and PSRBs on programme validation and programme accreditation/re-accreditation that supports a complementary approach on validating, accrediting and approving programmes. Its purpose is to avoid unnecessary overlap of processes and decrease administrative burdens for institutions. HEIs and PSRBs have been requested by QQI to consider endorsement of the Principles and institutions' names will be published on the QQI website.

The University Programmes Board (UPB) had considered the Principles document at its meeting on 11 October 2022. The document generated a considerable amount of discussion, in particular, with colleagues working directly with professional accreditation bodies. UPB recommended that UCD should not endorse the Principles. A briefing note on the discussions held at UPB (and ACQEC) was included for information.

Academic Council noted that there is no statutory requirement to implement the Principles. Meeting the requirements set-out in the Principles document would require additional resources and increase workloads. The benefit to the University in endorsing the Principals was unclear. Academic Council agreed that the University's key priority is to maintain the integrity of UCD awards and its programme offerings.

Academic Council was informed that other IUA universities have signed up and UCD would be an exception by not endorsing the Principles. However, UCD can decide to sign up at a later stage.

Decision Academic Council approved the UPB recommendation not to endorse the QQI *Principles for Professional Engagements with Education Providers, including Programme Validation, Professional Accreditation and Approval.*

4 UCD Intellectual Property Policy

The Director of Enterprise and Commercialisation, Tom Flanagan, was in attendance to speak to this item.

The revised Intellectual Property Policy was endorsed by UMT on 1 November and once ratified by Academic Council, will go to Governing Authority for final approval. The updated Policy ensures that UCD meets the new HEA requirement to update the policy every four years. Proposed changes to the Policy include:

- The Commercialisation Committee may recommend to UMT to share proceeds from an equity sale with inventors where the inventors do not receive a share of licence income.
- All UCD Spin-out Companies are required to make provision for a future Employee Stock Option Plan (ESOP) and founder equity to attract key executives to join the company in the preinvestment phase.
- UCD shall be protected from any dilution until such time as the Company shall have received more than €250,000 in cash.
- Royalties received by inventors will not contribute to their pension calculations.
- Disputes may be referred to mediation by a mediator agreed by the parties, or in default of agreement, appointed by the president of the Mediators Institute of Ireland.

During discussion concerns were raised regarding the ownership of IP (section 1.1). The wording surrounding the ownership of teaching materials should be more carefully nuanced to assuage any concerns academics may have, in particular, relating to online material/recordings. The way the section is currently written acts as a barrier to lecturers providing lecture content online. Of key priority to the University is that teaching materials continue to be made available to the student for their time in UCD even if a lecturer resigns.

Academic Council agreed that editorial changes are required to section 1.1 and a modified version will need to be resubmitted to Academic Council for approval in advance of submission to Governing Authority.

Decision Academic Council did not approve the updated UCD Intellectual Property Policy.

5 Amendments to the UCD Examination Regulations

Professor Peter Duffy, Chair of the Academic Council Committee on Examinations (ACCE), introduced this item.

Following on from the summer examination session, it was noted by Invigilators that students did not consider smart watches electronic devices and therefore did not remove them before exams. The Academic Council Committee on Examinations (ACCE) reviewed the Examination Regulations and updated them to clarify the definition of an electronic device. Academic Council agreed there should be no unintended consequences for those who use medical devices.

Decision Academic Council approved the amendments to the UCD Examination Regulations.

6 Amendment to Existing Subject Title

The Head of Subject, Professor Anne Keegan, introduced this item.

Academic Council considered the proposal to amend the subject title from 'Human Resources and Industrial Relations' to 'Human Resource Management and Employment Relations'. It was highlighted that the Subject Area has been called 'Human Resource Management and Employment Relations' for at least five years. The name change was introduced prior to 2017 but the requisite approval process for the

change was not completed at the time due to an oversight by the College.

Decision Academic Council approved the amendment to the existing subject title.

- ACEC Response to Academic Council Subcommittee Annual Reports 2021-2022

The Acting Registrar introduced this item.

In accordance with the Academic Council Standing Orders (section 5.4), Academic Council Subcommittees are required to submit an annual report to Academic Council. The Chair of each Subcommittee was given an opportunity to highlight areas of good practice and areas which require further consideration in the upcoming academic year. The ACEC Response provides a condensed overview of the discussion. The Acting Registrar acknowledged the important work conducted by the Subcommittees, and thanked Chairs and members for their contribution.

The Governing Authority wished to express its thanks to the Academic Council and provided a response to each of the points that were raised.
