# Minutes of the meeting of Academic Council Thursday 27 April 2023, 2pm Auditorium, UCD Village

Present: 59 In Attendance: 4 Apologies: 19

This meeting of Academic Council was chaired by the Acting President, Professor Mark Rogers.

The Chair informed members that items under Part 2 of the agenda are for decision en bloc and items under Part 3 are for information. Members were invited to indicate if they wanted any items from these parts moved to Part 1 for discussion. No items were raised.

Decision | Academic Council approved items from Part 2 and noted items from Part 3 of the agenda.

#### 1 Apologies

The Chair acknowledged that a number of apologies had been received.

#### 2 Minutes and Matters Arising

#### Minutes of the meeting held on 24 November 2022

The minutes of the meeting held on 24 November 2022 were approved.

#### **Matters Arising**

There were no matters arising from the minutes.

#### Part 1

#### ITEMS FOR DISCUSSION / DECISION BY ACADEMIC COUNCIL

#### 3 Academic Regulations Taught Regulations Review

The Dean of Undergraduate Studies, Professor Marie Clarke, introduced this item, provided the context to the review of the Taught Academic Regulations and outlined the extensive consultation process that informed the recommendations. The consultation process included Deans, Associate Deans, faculty,

College and School staff and Academic Council subcommittees. Professor Clarke also thanked members of the Working Group for their contribution, in particular the work carried out by Caoimhe Rehill, Office of the Registrar.

The Report provided a high-level overview of the work of the Working Group, a summary of the consultation and feedback process, recommendations of the Working Group and the proposed changes to the text of the Academic Regulations, as per the tracked changes version presented. Professor Clarke outlined each proposed amendment to the Academic Regulations and provided context where appropriate.

During discussion, the following points of note were raised:

- It was queried whether Regulation 3.6 which stipulates that 'a programme may not require a student to take more than 30 credits per trimester (including elective credit)', places a restriction on programme design and student options. It was clarified that while a programme cannot require a student to take more than 30 credits, a student may choose to take up to 40 credits.
- Regulation 3.7 relating to the 40-credit student workload limit was amended to give Governing Boards more authority to support students to manage their workload and ensure they do not carry too much in the form of resits and repeats.
- The Regulations stipulate that an IX module grade must be remediated within two trimesters of the initial attempt. More clarity should be provided in the Regulations to specify that the initial attempt refers to the initial offering (when the exam is set) which may be followed by two more attempts.
- It was recommended that a Working Group is convened to consider concerns from the student body that component assessments in module resits are capped at Pass/Fail.
- It was queried whether final year students may be allowed resit to enable them complete in time for graduation. It was recommended that a Working Group could look at this issue at a future point.
- Regulation 5.12 it was agreed to make an editorial amendment to remove an additional 'previously'.

Included in the Working Group Report was a number of high-level recommendations which include the establishment by Academic Council of a number of Working Groups to: maintain ongoing oversight and monitoring of the Academic Regulations to ensure they are responsive to University needs without reliance on formal periodic review; undertake a wider review of specified remediation practices; consider the functions and responsibilities of University Governing Boards, Programme Directors, Programme Examination Boards and School Modular Examination Committees; and consider how the Regulations apply to all overseas offerings, not just UCD Joint Colleges.

#### Decision

- Academic Council approved the changes to the Academic Regulations for implementation in September 2024.
- Academic Council approved the proposal to establish Working Groups to address issues identified in the Review.

#### 4 Review of Academic Regulations for Research Degree Programmes

The Dean of Graduate Studies, Professor Paul McCabe, introduced this item and gave a presentation on the proposed changes identified by the *Research Regulations Review Working Group* to the following research elements of the Academic Regulations:

- Section 7: Regulations for Research Degrees
- Section 8: Regulations for Professional Doctorate Degrees
- > Section 9: Regulations for the Degree of Doctor of Medicine (MD)

On the direction of the Working Group, UCD Graduate Studies coordinated an extensive consultation process that included feedback from Heads of School; school administrators, research student supervisors, the Academic Council Committee on Examinations, and the University Programme Board. Since the introduction of the Academic Regulations, UCD Graduate Studies continually monitored the research regulations and amendments were put forward for approval as needed, thereby minimising the need for a large number of updates in the present review. The proposed changes to the Academic Regulations will be implemented for September 2023.

In total the Working Group proposed 14 changes to the Regulations, 10 of which related to changes for minor edits; were discussed by the Working Group with no resultant change; or were changes made to reflect correct lines of responsibility (7.4, 7.23, 7.34, 7.40, 7.43, 7.46, 7.47, 7.52, 7.58, 7.68).

Other substantive changes to the Regulations related to the following sections:

- > 7.13 Relationship /engagement between research student and supervisor
- > 7.14 Lack of clarity on the eligibility of Research Fellows to act as supervisors
- > 7.16 Appointment of a replacement Principal Supervisor
- > 7.45 Number of attempts a candidate may make at the Stage Transfer Assessment

During discussion, the following points of note were raised:

- Regulation 7.13 relating to the relationship/engagement between research student and supervisor. It was queried whether consideration might be given to the role of 'joint supervisors' rather than 'principal and co-supervisor'. It was clarified that a principal supervisor is necessary to ensure that one person takes overall responsibility, however, the role of co-supervisor should not be diminished. It was suggested that the wording could be enhanced to better reflect the work undertaken by the co-supervisor. It was also recommended that a Working Group look at supervisory teams and consider if the team might be expanded (i.e. postdoctoral students/staff on contracts of indefinite duration) without having a negative impact on students.
- ➤ Regulation 7.16 relating to the appointment of a replacement Principal Supervisor. Guidance should be provided in the event that a Head of School, having made every effort, cannot find a replacement Principal Supervisor. The wording should be amended to allow that in the unlikely or exceptional event that a Principal Supervisor cannot be found, the student should be referred to the Graduate Research Board for consideration who will work cross-college to find a solution, up to and including discontinuation of studies.
- Regulation 7.43 relating to the broadening of eligibility for membership of the Stage Transfer Assessment Panel (STAP). It was clarified that while the Panel used to consist of at least three permanent members of faculty it will now 'normally consist of 3 members of the faculty of the University at least one of which is a permanent member of faculty'. This change is to be incorporated into the final document. Furthermore, only members of the adjunct and visiting staff of the University who have been 'approved to act as supervisors, and are included on the Register of Adjunct/Visiting Supervisors', are eligible for membership of the STAP. Temporary faculty (e.g. Ad Astra) may not be members of the STAP.

Through the consultation process, the Working Group noted a significant amount of feedback relating to the Recognition of Prior Learning (RPL) Policy. However, RPL is deemed to be outside the scope of this Working Group and therefore it is recommended that the consultation feedback should be re-directed by Academic Council to the relevant policy owner (UCD Admissions).

Academic Council approved the changes recommended by the Research Regulations Review
 Working Group to Sections 7, 8 and 9 of the UCD Academic Regulations subject to an

additional clarification being added to regulation 7.16.

 Academic Council agreed to establish a Working Group to consider the appropriate appointment of co-supervisors.

# PART 2 ITEMS FOR APPROVAL BY ACADEMIC COUNCIL

#### 5 Policy for Research Degree Examination

Following approval by the Academic Council Executive Committee at its meeting of 26 May 2022, a Policy Development Working Group was established to develop a policy that comprises the whole examination process for research students. The Policy is supported by a Guidelines document which outlines the associated processes and procedures. The advantage to the research student is that all information will be held in these two documents, currently students must navigate four separate documents, held in different repositories to obtain comprehensive information on the preparation, submission, processing, examination, and dissemination of graduate research degree theses.

Decision Academic Council approved the Policy for Research Degree Examination for implementation in September 2023 in line with the introduction of revised UCD Academic Regulations for Research Degrees.

#### **6** University Academic Calendars

- a) Commencement of Autumn Trimester Teaching Term 2023-24 Stage 1 UG students
- b) Proposed Academic Calendars 2024-25 to 2030-31

Academic Council sets the University's Academic Calendar following consultation with key operational stakeholders on a cyclical basis. Academic Council was asked to (a) approve a revised start to the teaching term for incoming Stage 1 UG students due to the likely delayed release of Leaving Certificate results in September 2023, and (b) approve the Academic Calendar for 2024-25 and the six subsequent academic sessions.

#### Decision

- Academic Council approved the proposal that in the likely event of the delayed release of Leaving Certificate results, the teaching term for incoming Stage 1 UG students will commence on Monday 25 September 2023.
- Academic Council approved the Academic Calendar for 2024-25 through to 2030-31.
