His research has focused most recently on the collective organisation of the judiciary as a professional interest group and its implications for the separation of powers. - This programme is intended for applicants with a Law degree, or an interdisciplinary degree in which law was a major component. An upper second class honours, or international equivalent is required.
- Applicants whose first language is not English must also demonstrate English language proficiency of IELTS 6.5 (no band less than 6.0 and 6.5 in reading and writing), or equivalent.
