Roles and responsibilities

- 1. To guide the student in completing the Clinical Competence Assessment Tool (CCAT) and Clinical Learning Outcomes (CLO), a framework for student learning and feedback. This includes conducting a preliminary, mid-point and endpoint meeting in collaboration with the student to identify and meet clinical learning objectives. The clinical assessment is an ongoing process from competent General Practice Nurse(GPN)/Community Nurse (cRGN) to Expert GPN/cRGN.
- 2. Provide clinical supervision for students or support students in sourcing appropriate clinical persons to complete competence assessment for Primary Care skills.
- 3. Provide guidance for students to achieve 30 hours of planned clinical exposure hours.
- 4. Provide and document timely feedback to the student and communicate with the Programme Director as required during the course.
