CMS: Module Descriptor Edits Closing Friday, 8 September

Edits to descriptors via the [My Modules](#) menu of the [Curriculum Management System](#) (CMS) will close on Friday, 8 September. The [Module Descriptor Change Request Form](#) that has been used to record final amendments to Requirements/Prior Learning, Student Effort Hours, Credit Split by Trimester, Module Status and Trimester for Delivery will also close on the same day.

Arrangements for Module Descriptor Amendments from Monday, 11 September

- From Monday, 11 September, amendments to modules commencing in the Autumn trimester will require approval as an [exemption](#) on the basis of exceptional circumstances.
- There will be further opportunities to amend modules commencing in the Spring and Summer Trimesters later in the Academic Year. Please see the published [Module Descriptor Edit Timelines](#) for further details.
- Updates to module places may be made by contacting systems.data@ucd.ie.
- Module Coordinator changes may be made year-round via Module List Management – [Update Module Details](#).

Incomplete or inaccurate descriptors have operational implications for the smooth running of registration, assessment and grading processes. Please review your descriptor to ensure that:

- Purpose and overarching content, learning outcomes and approaches to teaching & learning are articulated
- The mode of delivery accurately reflects how the module will be delivered to students
- The student effort hours are recorded and are appropriate for the module credit value (1 x ECTS = 20-30 hours student effort)
- Assessment (including type, grade scale, weighting), remediation and feedback strategies are reviewed and are accurate
- Details of the staff/faculty associated with the module are reviewed so that only those with current requirement to view module and student information have this access
- Any additional information (reading lists, internship indicator, prior learning) is recorded as required.

This information has also been circulated to Module Coordinators and the communication is included below for reference.

Major Structures Amendments

The [Structure Change Request Form](#) that has been used to record final changes to majors will also close on Friday, 8 September. From Monday, 11 September changes to structures such as those below will require approval as a programme change by your Governing Board (via a [PDARF16](#) form):

- Amendments to available modules
- Alterations to the balance of core and option credits
