## Curriculum Management Update: Final Changes to Modules/Major Structures

Please see below updates on module descriptor and major structure edits for the upcoming Academic Year.

### CMS: Module Descriptor Edits Closing Friday, 10 September

- Edits to descriptors via the [My Modules](#) menu of the [Curriculum Management System](#) (CMS) will close on **Friday, 10 September**.
- The [Module Descriptor Change Request Form](#) that has been used to record final amendments to Requirements/Prior Learning, Student Effort Hours, Credit Split by Trimester, Module Status and Trimester for Delivery will also close on the same day.

### Arrangements for Module Descriptor Amendments from Monday, 13 September

- From **Monday, 13 September**, amendments to modules commencing in the Autumn trimester will require approval as an [exemption](#) on the basis of exceptional circumstances.
- There will be further opportunities to amend modules commencing in the Spring and Summer Trimesters later in the Academic Year (see the published [Module Descriptor Edit Timelines](#) for further details).
- Updates to module places may be made by contacting [systems.data@ucd.ie](mailto:systems.data@ucd.ie).
- Module Coordinator changes may be made year-round via [Module List Management – Update Module Details](#).

### Key Reminders for Finalising Module Descriptors

- **Module Descriptor Accuracy:** completed descriptors allow students to make fully informed decisions when selecting their modules for the upcoming Academic Year. Incomplete or inaccurate descriptors also have operational implications for the smooth running of registration, assessment and grading processes.
- **Mode of Delivery:** please ensure that the mode of delivery field is reviewed and updated **from online or blended to face-to-face** as necessary for your module. This provides clarity for students presented with in-person scheduling information on SISWeb that conflicts with the designated module mode of delivery and is in line with recent communications from the [President](#) and Registrar about on-campus teaching delivery.
- **Scheduling of Autumn End-of-Trimester Exams:** in order to meet overall capacity and demand for end-of-trimester exams (both in-person / online) that will be required for scheduling in the Autumn session, colleagues are reminded to please plan for continuous assessment where this is possible for your module. Furthermore, it is requested that resit assessments should also be completed during the teaching period where circumstances permit. Further details on plans for Autumn examinations will be circulated by Assessment, UCD Registry shortly. ### Major Structures Amendments

- The [Structure Change Request Form](#) that has been used to record final changes to majors will also close on **Friday, 10 September**
- From **Monday, 13 September** changes to structures such as those below will require approval as a programme change by your Governing Board (via a [PDARF16](#) form):
  - Amendments to available modules
  - Alterations to the balance of core and option credits
