We write to highlight a few items for you regarding the Autumn 2024/25 Grade Approvals Process ahead of the Christmas break. We acknowledge that there is a lot of information contained in this email, therefore, please refer back to it throughout the GAP process.

Timelines:

Please see the Assessment Key Dates and the attached pdf timeline.

Module Coordinators:

• Check your module(s) Assessment Strategy set up in advance of entering grades. This can be done either through the Curriculum Management System and is also available in your module(s) Grade Information page accessed through your My Module Grades.

Changes to Assessment Strategies are requested through Module Exemption requests. Please also check if your modules are missing any essential grading information in Missing Data from 2024/25 and also for modules Missing Data from 2023/24 that you may still be grading (e.g. January and May starts).

- Review the Grade Entry Guides and Videos.
- All grades should be entered via the Grade Entry system. Grades should be audited, reviewed, observations entered where required, and signed off by 12pm Wednesday, 15 January 2025 unless otherwise advised by your School.
- The Grade Entry system will remain open to you until 5pm Wednesday, 22 January
 2025 to accommodate entry of any amendments that may be required arising from

School Modular Examination Committee recommendations.

- If you require Brightspace support the Brightspace team in IT Service are available by clicking on IT Services Support Hub.

Schools:

- Please review if your modules are missing essential grading information in Missing Data from 2024/25 and in Missing Module Data from 2023/24 that you may still be grading (e.g. January and May starts).
- The SMEC period runs from Wednesday, 15 January to Wednesday, 22 January.
- Use the "Modules with Outstanding Grades" and "Modules with Outstanding Sign Off" columns in your School Grading Summary to follow up with Module Coordinators to ensure all grades are entered and signed off. The Exceptional Grade Change process cannot be used for grades that were left blank and grade entry for these may be delayed until a future Grade Approvals Process.

Colleges/Programmes:

- Use the Programme Audit Reports to perform your pre-GAP auditing. In particular the Stage Anomalies and Credit Anomalies reports should be used to ensure your students' module registrations are accurate. All registration issues should be resolved by Wednesday, 22 January.
- Programme Exam Board meetings take place on Tuesday 28, and Wednesday,
 29

January 2025 and all PEBs must be signed off by 5pm on Wednesday, 29 January to allow results to be released to students on Thursday, 30 January 2025.

Support available:

- The Grading Support team will be running drop-in zoom calls every weekday from **Wednesday 8th January to Wednesday 22 January**. The times and links are available through the Grading Support drop-in zoom calls calendar.
- The purpose of these drop-in sessions is to assist Module Coordinator's with Grade Entry in Infohub, and to provide support to Schools and Programmes in advance of their exam boards.
