INTRODUCTION

This research is part of Atlantic Futures - a €4 million, four-year crossborder project funded by the North-South Research Programme under the Shared Island Fund. As one of six research streams, this research is led by University of Galway, University of Limerick, and Ulster University, focusing on business scaling across the West of Northern Ireland and the Republic of Ireland. Through cross-border collaboration, it delivers strategic insights, addresses regional challenges, and drives sustainable growth.

RESEARCH RATIONALE

The West of the island of Ireland faces persistent economic challenges. By linking three regional hubs, Derry~Londonderry, Galway, and Limerick, we address shared issues through place-based, collaborative research that strengthens research culture and supports regional growth.

AIM

The aim of this research is to:

- Understand the key enablers & barriers of business scaling across the island
- Identify cross-border advantages and disadvantages
- Foster long-term academic collaboration, cultural awareness and partnership

RESEARCH TEAM

By working across institutional, geographic, and disciplinary boundaries, the team exemplifies a diverse, integrated research culture that supports mutual learning, innovation, and inclusive academic practice.

- All-island research collaboration between University of Galway, University of Limerick, and Ulster University
- Team includes both early-career and senior researchers, promoting mentorship and experience-sharing
- Regular virtual meetings and in-person workshops facilitate active engagement and sustained collaboration

- Engagement with key stakeholders fosters knowledge for inclusive and sustainable regional development.
- Provides strategic insights into regional differences in scaling across the island
