# **NEW FUNDED PROJECTS**

## IRC NEW FOUNDATIONS 2020 - 21 CALL:

A total of 94 eligible applications were received and evaluate by the IRC and 76 applications were recommended for funding. Congratulations to Marie Keenan, Muireann Ní Raghallaigh and Karen Smith on their successful awards:

• Marie Keenan Developing a theoretical framework on prostitution with the National Women's Council which is compatible with their goal of achieving gender equality and is informed by evidence and consultation with their members.

Abstract: This research aims to develop a theoretical framework on prostitution with the National Women's Council which is compatible with their goal of achieving gender equality, respects individual choice and sexual autonomy, and also recognises how individuals are constrained in their choices by structural, socio-economic and cultural forces. It aims to develop a critical understanding of consent within the prostitution contract and whether the buying of sexual access to *some* women's bodies undermines the movement for meaningful sexual consent for all. A key question is the impact of framing prostitution as a positive choice on marginalised women who populate the global sex trade.

• Karen Smith, *Community Sponsorship Ireland: a participatory approach for increasing sustainability.* Abstract: In 2019, the government of Ireland launched a refugee resettlement programme called Community Sponsorship Ireland (CSI). Worldwide, other countries are implementing similar policies, modelled on a Canadian initiative. Limited research evidence makes ongoing critical review of the policy essential. Issues of equality and exclusion including gender and race are typically overlooked in the monitoring and evaluation of such policies. In partnership with the Regional Support Organisation Nasc and refugee peer researchers, this project will develop a guide setting out principles and guidelines for a participatory feedback and monitoring approach taking into account relevant issues related to power, equality and inclusion.

• Muireann Ní Raghallaigh, Perspectives of refugees on questions of participation, power and ethics in research.

Abstract: Through engaging in collaborative discussions and processes of reflection with asylum seekers, refugees and refugee activists, this research will develop an understanding of how refugees experience participation in research and how 'engaged research' might be done more collaboratively and ethically. It also explores how academic researchers and refugees can genuinely co-create knowledge that more meaningfully contributes to activism and social change. As well as being a standalone study, the project will lay the foundation for the methodological approach to a comparative study of refugee integration in Ireland and Scotland, as part of the Scottish Irish Migration Initiative (funding dependent).

### WUN RESEARCH DEVELOPMENT FUND, 2020 CALL

Congratulations to Dr Orla Kelly, UCD School of Social Policy, Social Work and Social Justice who was awarded funding to lead a new Interdisciplinary Research Group with funding from the Worldwide Universities Network (WUN) Research Development Fund (RDF) 2020.

This project, entitled *Education in a Warming World: A Collaborative Research Network on Education and Climate Change* draws together a team of 14 co-investigators from the UK, Europe, Australia and Africa.

The team will explore new research partnerships on a broad range of topics at the intersection of climate change and education and will produce a best practice framework for promoting a robust climate change and sustainability education agenda at institutes of higher education.

**Bio**: Maya Goodfellow is a writer, broadcast commentator and academic. She is the author of Hostile Environment: How Immigrants Became Scapegoats. She is currently a Leverhulme Early Career Research Fellow at SPERI, University of Sheffield and a visiting fellow at the Sarah Parker Redmond Centre for the Study of Race and Racialisation at UCL.

**Summary abstract**: The seminar examines how anti-immigration arguments are often articulated. Using the UK as a case study, it shows how they are rooted in Empire and ideas of race. Ultimately it considers alternative ways of understanding movement and of thinking about how to challenge processes of bordering.

This event, chaired by Assoc. Prof. Nessa Winston was attended by over 60 participants and was followed by a very lively Q&A session. This seminar was organised in conjunction with UCD Earth Institute Sustainable Communities Research Theme 2020 2021.

**Bio**: Dr Jeanne Moore primarily works on climate and sustainable development projects in NESC, most recently on a just transition, sustainable recovery from Covid 19 and climate policy Previous Council work has examined the social and behavioural aspects of climate change, circular economy, and environmental policy integration, community engagement in wind energy and the role and future of environmental data Jeanne has also worked on quality and standards in disability services As part of her role, she has contributed to Council Reports, represented NESC on advisory committees, addressed conferences and policy forums and presented to the Oireachtas Committee on Climate Change Prior to this role, Jeanne was a lecturer in

social and environmental psychology at the University of Teesside, UK

**Summary abstract**: This seminar draws on recent work conducted by NESC on just transitions, outlining key challenges identified on how positioning the response to economic vulnerability within a just transition framework throws light on the need for particular governance tools and processes. These include widening the evidence to be considered, developing social dialogue processes and adopting a place based approach to delivering solutions. It will also reflect on the challenge ahead aligning just transition policies with decarbonisation measures is necessary to ensure emissions are radically reduced, but in a way that is fair, inclusive and equitable.
