The MSc in Social Work, Welfare and Justice is designed for practising social workers interested in refining their analytical and management skills through post qualifying studies, and anyone who wishes to pursue research careers in policy making and analysis in the fields of social policy and social justice.

The programme focuses on a range of topics of relevance to policy makers and practitioners. In recent years, the work environment for social work practitioners is becoming globalised.

In addition, social justice and equality issues are an increasingly prominent concern in the social scientific research.

The Programme provides a range of learning opportunities across a wide range of topics, including: housing, health and social care, drugs and alcohol in the community, theory and practice in social work, gender equality, environment, migration, family and social protection.
